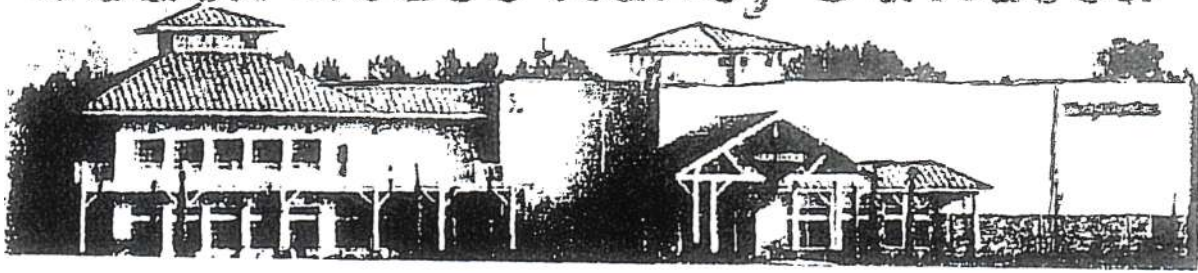

1. THIS VENDOR APPLICATION IS FOR BEACH HOUSE HARLEY DAVIDSON OPEN HOUSE INCONJUNCTION WITH MYRTLE BEACH BIKE WEEK, MAY 13-22, 2011. IT WILL BE A 10 DAY RALLY. SET UP IS THURSDAY, MAY 12TH.
2. NO DRUG PARAPHANELIA, ADULT TOYS, PORNOGRAPHIC MATERIAL, OR OTHERWISE OFFENSIVE MATERIAL WILL BE ALLOWED TO BE SOLD. NO T-SHIRTS OF ANY KIND CAN BE SOLD.
3. THE VENDOR FEES: 10X10, 10X20, OR UP TO A 20X20 IS \$200.00 PLUS 10% OF GROSS SALES, AND A \$25.00 GIFT CERTIFICATED 20 X40 IS A FLAT RATE OF \$1,000.00 PLUS A \$50.00 GIFT CERTIFICATE. THE VENDOR FEE DOES NOT INCLUDE THE PERMIT FEE WHICH IS \$100.00. VENDORS MUST HAVE LIABILITY INSURANCE IN THE AMOUNT OF \$1,000,000.00 WITH BEACH HOUSE HARLEY DAVIDSON NAMED AS ADDITIONAL INSURED. A COPY OF THIS INSURANCE CERTIFICATE MUST BE SENT TO BEACH HOUSE HARLEY DAVIDSON. VENDOR FEE AND PERMIT FEE IS DUE APRIL 15, 2011. ALL TENTS MUST BE RATED A **701** FIRE TENT. ALL FOOD VENDORS MUST APPLY FOR AND OBTAIN A BRUNSWICK COUNTY HEALTH DEPARTMENT PERMIT REGARDLESS OF ANY OTHER PERMIT THEY MAY HAVE. THE FEE FOR SPRING 2010 SHOW WAS \$75.00. **IT IS THE SOLE RESPONSIBILITY OF THE FOOD VENDOR TO OBTAIN THIS PERMIT. IF THEY FAIL TO DO THIS OR DON'T PASS INSPECTION BY THE HEALTH DEPARTMENT THERE WILL BE NO MONEY REFUNDED.**
4. NO TRAILERS OR RV'S WILL BE ALLOWED IN VENDING AREA UNLESS THAT FIT INTO YOUR VENDING AREA. A DESIGNATED AREA WILL BE PROVIDED FOR VENDOR'S RV'S, CARS, AND TRAILERS NOT PARKED IN THEIR VENDING AREA. ALL RV'S PARKED IN THE VENDING AREA, OR ON THE LOT WILL BE CHARGED \$150.00. RV HOLDING TANK DUMPS WILL BE \$35.00.
5. LIMITED ELECTRIC HOOKUPS ARE AVAILABLE. 10 AMP IS \$100.00 AND 20 AMP IS \$150.00 EACH VENDOR IS LIMITED TO EITHER **ONE 10 AMP OR ONE 20 AMP PLUG.** ELECTRICITY IS LOCATED APPROXIMATELY 100 TO 300 FEET FROM YOUR VENDING AREA.
6. VENDORS ARE GUARANTEED THEIR SPACE MAY BIKE WEEK RALLY WITH A \$100.00 DEPOSIT.
7. IF I, RAY HERRO, LOSE THE LEASE AT BEACH HOUSE HARLEY DAVIDSON FOR ANY REASON, I WILL ONLY BE RESPONSIBLE FOR RETURNING YOUR VENDOR FEE. VENDORS CANCELLING 30 DAYS BEFORE THE SHOW WILL BE REFUNDED 50% OF THEIR BOOTH FEE AND 100% OF THE PERMIT.
8. VENDORS ARE RESPONSIBLE FOR COLLECTION OF AND REMITTING ALL SALES TAXES AND ALL PERMITS REQUIRED FOR SALES TAX. YOU WILL HAVE TO HAVE A N.C. SALES TAX PERMIT.

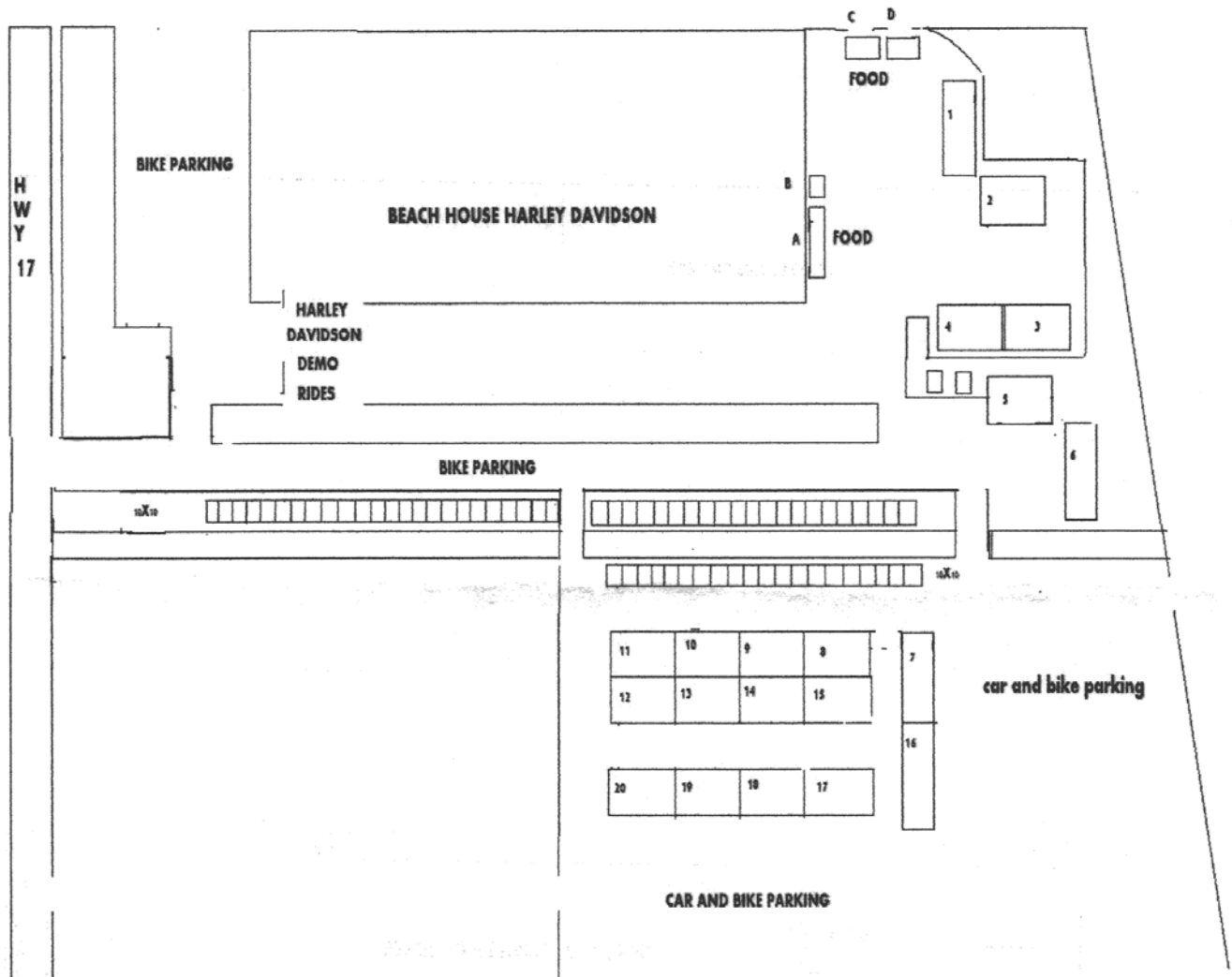

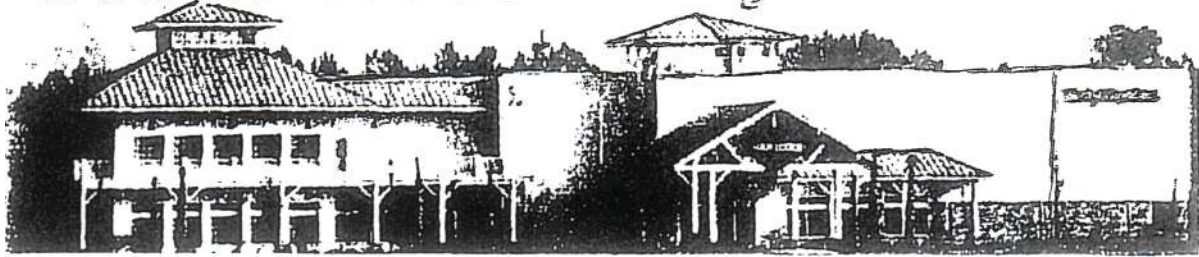
